Since January 2015, Mark D. Cole is Professor for Media and Telecommunication Law at the University of Luxembourg, where he

previously was Associate Professor for the Law of the New Information Technologies, Media and Communications Law since 2007. He is also Course Director for the Master in General European Law LL.M. programme (SatComMediaLaw track). In addition, he is a Faculty Member of the Interdisciplinary Centre for Security, Reliability and Trust (SnT) of the University of Luxembourg. Since July 2014, he holds an additional position as Director for Academic Affairs at the Institute of European Media Law (Saarbrücken/Brussels).

Mark Cole studied law and political science and holds a doctorate from the Johannes Gutenberg Universität Mainz (2003) where he was research assistant from 1999 to 2002 and again from 2005 to 2007 at the Chair in Public Law, International and European Law, Media Law. Additionally, he holds both German State Examinations in Law. He gained practical experience in media law at the DG Competition of the European Commission, a law office specialising in Intellectual Property Law and the legal department of a television broadcasting company. For three years he was Researcher at the Mainz Media Institute where he still teaches a class on European Media Law in the LL.M.-programme on Media Law; at the Europainstitut Saarbrücken he gives a yearly course on European Media Competition Law. At the University in Saarbrücken he is co-director of the Institute for Legal Informatics. In Luxembourg he is Member of the Advisory Committee of the Independent Audiovisual Authority of Luxembourg (ALIA, Autorité Luxembourgeoise Indépendante de l'Audiovisuel).

Mark Cole is co-editor of the commentary "Rundfunkstaatsvertrag/ Jugendmedienschutzstaatsvertrag - Heidelberger Kommentar" since 2008 and of the forthcoming "The EU Audiovisual Media Services Directive - Comparative Commentary on the AVMSD and National Implementation, Nomos Hart Beck" (with Jenny Metzdorf); he is (co-)editor of European Data Protection Law Review (EdpL), Revue du Droit des Technologies de l'Information (R.D.T.I.) and International Journal of Law and Information Technology (IJLIT).

Thomas Gibbons is a Professor of Law at the University of Manchester. He was Dean and Head of the School of Law from 2000 to 2003. His main research interests are in media and communications law and regulation. He is a founding editor of the Journal of Media Law, and his publications include Regulating the Media (Sweet & Maxwell, 1998) and Audiovisual Regulation under Pressure: Comparative Cases from North America and Europe (with Peter Humphreys, Routledge, 2012).

Dr Chris Marsden is Professor of Internet Law at the University of Sussex. He is author of four monographs on Internet and new media law: "Regulating Code" (2013, MIT Press with Ian Brown), "Net Neutrality: Towards a Co-Regulatory Solution" (2010, Bloomsbury), "Internet Co-regulation" (2011, Cambridge), and "Codifying Cyberspace" (Routledge 2007). He is also author-editor of the interdisciplinary Internet policy books "Regulating the Global Information Society" (Routledge 2000), and "Convergence in European Digital TV Regulation" (Blackstone/OUP 1999).



He is author of many refereed articles, book chapters, professional articles, keynote addresses, and other scholarly contributions. He has been research fellow at Cambridge, Oxford, Warwick, Harvard, Melbourne, and Keio (Japan) and was previously professor at Essex. He advises governments, human rights organisations and others and frequently is quoted in the media. He co-authored the impact assessment contributions for both the European Commission and Ofcom on the draft AVMSD in 2005-6 and authored an expert study for the Council of Europe on new media regulation in 1999.

<u>Peggy Valcke</u> is research professor ICT and media law at <u>KU Leuven</u>, and visiting professor at the <u>University of Tilburg</u>. In 2014, she was parttime professor at the <u>European University Institute</u> in Florence, and in 2006, she was visiting professor at <u>Central European University</u> in Budapest, Hungary. She is member of the management board of the Leuven Centre for IT & IP Law (formerly known as ICRI and CIR), and one of the research leaders in the Security Department of <u>iMinds</u>.



Peggy has a broad experience with working in international and interdisciplinary research teams. In previous years she has been involved in over 30 research projects - funded by the European Commission, KU Leuven, Fund for Scientific Research-Flanders, the Agency for Innovation by Science and Technology, iMinds, national authorities and regulators - dealing with legal aspects of IT and media innovation. In 2008-2009, she served as project leader for the EU funded study "Indicators for Media Pluralism in the Member States - Towards a Risk-Based Approach". Other topics she worked on include: fundamental rights of the digital citizen, data protection and media freedoms, data portability, right to be forgotten, big data, media convergence, social media, personalized media, user-generated content, online journalism, media concentration and ownership, market regulation and competition in media and telecommunications, public service broadcasting and state aid, co- and self-regulation in the media, privacy in electronic communications and social networks. She has published widely on these topics in English, Dutch, French, German, Hungarian and Chinese, and has served as an expert for organisations like the European Commission, the Council of Europe, the German Media Concentration Commission, as well as administrations and authorities in Belgium.

Peggy is assessor of the <u>Belgian Competition Authority</u> and member of the General Chamber of the <u>Flemish Media Regulator</u> since 2008. She was a member of <u>Google's</u> <u>Advisory Council on the Right to be Forgotten</u> and is currently a member of <u>Digital Minds for</u> <u>Belgium</u>, a working group convened by Belgium's Minister for Telecommunications and Digital Agenda (A. De Croo).

Dr. Dieter Dörr has been a Professor of Public Law, European and International Law, Media Law at the Johannes Gutenberg University of Mainz since 1995 and has been the Director of the Mainz Media Institute since 2000. He completed his Ph.D. at University of Saarbrücken in 1983 and his Habilitation (post-doctoral degree) at University of Cologne in 1987. He has specialized in German, European and International Media Law, covering both traditional mass media as well as the law of the new information technologies. From 1988 to 1990 he was first a visiting professor and then a professor at the Institute of International Affairs of the University of Hamburg. From 1990 to 1995 he was the Director of Legal Affairs for the



Saarländischer Rundfunk, the public broadcasting corporation of the German state of Saarland. In 2000 he was appointed to the Commission on Concentration in the Media (KEK), whose chairman he was from October 2004 to March 2007. Since 2003 he has been a Judge of the Regional Court of Appeal (Oberlandesgericht) Koblenz.
